Common questions

Who is eligible for the AECT dividend?

Everyone who is an AECT income beneficiary when the dividend roll is struck. You are an AECT income beneficiary if you are a Vector electricity customer in the Trust District of Auckland, Manukau and northern Papakura. The dividend is paid regardless of who your electricity retailer is, as long as your name is on the power bill. In the case of rental properties, this is usually the tenant rather than the owner of the building.

When will the dividend be paid and how much will it be?

The dividend is usually paid in September/October. The amount depends on the financial results from Vector, which won't be known until later in the year. Last year it was \$320.

What happens if I move before the dividend is paid?

As long as you are within the Trust District when the dividend roll is struck, you will still receive the dividend. Your details will be included in the roll we receive from your electricity retailer later in the year. But if you move out of the Trust District before the roll is struck, you won't be eligible for the dividend. Please note, some apartment buildings and residential developments inside the Trust District do not qualify for the dividend because they do not use the Vector electricity network. How do I get the dividend paid straight to my bank account?

It's quick and easy. Just fill out the form and make sure everyone named on the power bill signs it.

You must send the form back by 12 August 2011.

But please note, if you move or change electricity retailers after you send the form back, we may not be able to match your details and pay the dividend to your bank account. Instead, you will receive a cheque, provided you are still an income beneficiary on the roll date. For more details, see the back of the form or go to www.aect.co.nz

You love the AECT dividend. We love that the power's in your hands!

A major benefit of the AECT owning 75.4% of Vector is that the Trust gets a share of the profit Vector makes every year. This is then shared with our beneficiaries – you. Last year, that meant a \$320 dividend to over 300,000 households and businesses, totalling almost \$100 million into the Auckland economy – and \$988 million since dividend payments began! This year's dividend payment will depend on Vector's profit, and we'll talk to you later in the year about that.



Get your dividend first!

Fill in the enclosed form to let us know your bank details, and your dividend payment will be in your bank account the day it's paid. If we don't have your bank details, it might take a little longer as you'll receive a cheque instead.



What is the AECT?

The AECT or Auckland Energy Consumer Trust is the majority shareholder of Vector. The Trust was set up in 1993 on behalf of electricity consumers in the old Auckland Electric Power Board area to ensure that power lines remained in the control of electricity consumers. In the early days, Vector was simply a power lines company. Look how things have changed! Vector has grown to become one of New Zealand's leading multi-infrastructure companies, but it is still proudly, locally, majority-owned by the AECT on your behalf.

- The money will be paid to the person or organisation whose name is on the power bill.
- If the name on your power bill is not the same as your bank account and you want to get your dividend as a cheque or direct credit, please update your details with your electricity retailer – the AECT can't do this for you.
- If you want to get your money faster, please fill out and return the direct credit form from this pack.
